In order to be eligible for nomination, you must complete and submit the following documents to the Chief Electoral Officer at least seven (7) days **BEFORE** the Nomination Meeting (no later than July 5, 2023).

- a) Written Declaration of Eligibility (Appendix E)
- b) Required Affidavit/Declaration (Section 6.7c)
- c) Complete Criminal Record search report (not more than 6 months old)

REMINDER: In addition to the above documents being submitted on time, you will also need to be Nominated and Seconded by eligible Voters (in accordance with section 6.1-6.4) and all nominated Candidates must reside within the traditional territory of the Metlakatla First Nation and (as stated in section 6.5):

- a) Be present at the meeting and accept their nomination verbally;
- b) Have given written authorization to the nominator to let their name stand; or
- c) Have given their written and signed authorization to the Chief Electoral Officer to let their name stand prior to the close of the Nomination Meeting.

When all of the requirements above have been met, you will be able to complete the "Post-Nomination Instructions & Forms" Package within 48 hours of the close of the Nomination Meeting.

Any elector who does not comply with the requirements as set out in the *Metlakatla First Nation Election Code*, 2019 will not be eligible for nomination.
